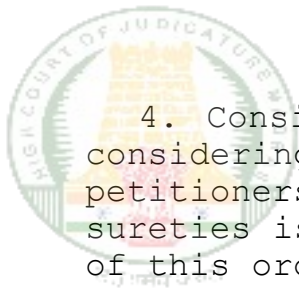

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.3009 of 2021 dated 11.03.2021, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioners would submit that due to due to ill health of the first petitioner, they are unable to arrange sureties and could not appear before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

4. Considering the facts and circumstances of the case and also considering the submission made by the learned counsel for the petitioners this petition is allowed and the time for producing the sureties is extended by two weeks from the date of receipt of a copy of this order as a last chance.
