This petition has been filed to grant permission to withdraw the amount for a sum of Rs.5,00,000/- which was deposited by the respondent in the credit of M.C.No.25/2014 on the file of the learned Chief Judicial Magistrate, Karur, as per the order of this Court dated 03.06.2019 in Crl.M.P(MD) No.4371 of 2019.



2.The learned counsel for the respondent has no objection in permitting the petitioner to withdraw the said amount, since it is a maintenance amount.

3.Accordingly, this Criminal Miscellaneous Petition is allowed and the petitioner is permitted to withdraw a sum of Rs.5,00,000/- which is lying in the credit of M.C.No.25/2014 on the file of the learned Chief Judicial Magistrate, Karur, by filing necessary application before the concerned Court.
