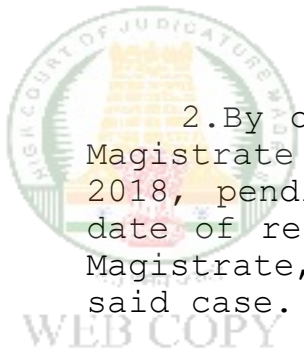
Prayer :-
