PETITION FOR ANTICIPATORY BAIL Under Section 438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No. Not known of 2021 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioners/ accused , who apprehend arrest at the hands of the respondent police for the alleged offences punishable under Sections 294(b), 341 and 506(ii) of IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 1998, in Crime No.not known of 2021, seek anticipatory bail.

2.Today, when the matter is taken up for hearing, the learned Government Advocate(Criminal Side) appearing for the respondent Police submitted that the First Information Report has been registered against the petitioners in Crime No.141 of 2021 for the offences under Sections 294(b), 352 and 506(ii) of IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.



3. In view of the same, the petition is dismissed with liberty to the petitioners to work out their remedy in the manner known to law.
