4.This petitions are ordered, accordingly.

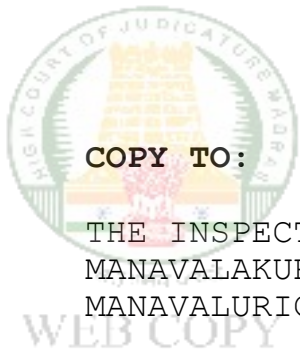
