ORDER

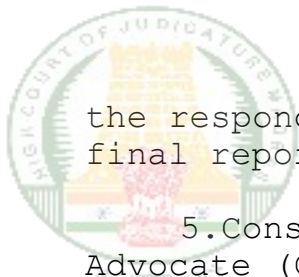
The present petition is filed seeking a direction to the respondent to file a final report in Crime No. 113 of 2018.

2.The case of the prosecution is that due to previous enmity between the petitioner and the accused, A-1 attacked the petitioner in his left side head, above the elbow on the left hand of the petitioner and also sustained grievous injuries. Therefore, the petitioner lodged a complaint before the respondent police and a case in Crime No.113 of 2018 was registered for the alleged offence under Sections 147, 148, 294(b), 323, 324 and 506(ii) of IPC. In the meantime, the accused persons lodged a false complaint against the petitioner before the first respondent police and a case in Crime No.112 of 2018 was registered and it is a counter case and both cases are now pending. Hence, the petitioner filed the present petition before this Court.

3.Heard the learned counsel on either side.

4.The learned Government Advocate (Criminal side) appearing for
