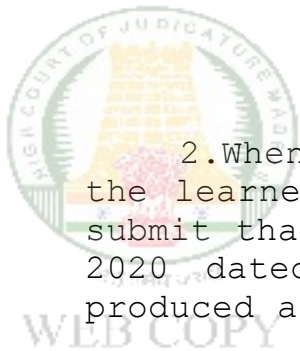
Prayer in WP(MD). 1908/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Directing the respondents to pay interest at the rate of 18 percent per annum, for the period of delay from 01-10-2018 to 21-09-2019, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution, Gratuity, Encashment of Earned/Sick Leaves and Commuted Value of Pension, within a time frame as may be fixed by this Honourable Court and without affecting his right to claim balance amounts towards those benefits.
