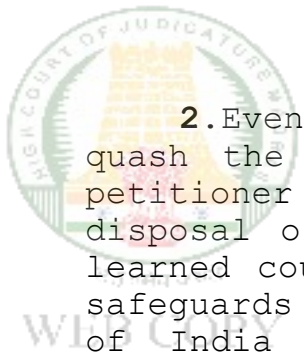
PRAYER : Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Habeas Corpus, or any order or direction or to issue a Writ in the nature of Habeas Corpus, calling for the entire records connected with the detention order passed in No.18/BCDFGISSSV/2021 dated 30.03.2021 on the file of the second respondent herein and quash the same and direct the respondents to produce the detenu or body of the detenu namely the petitioner's son ie., Sudalaimuthu, aged about 23 years, S/o.Chellaiah, now detained at the Central Prison, Palayamkottai, before this Court and set him at liberty forthwith.

O R D E R

(Order of the Court was made by V. BHARATHIDASAN, J.)

This Habeas Corpus Petition has been filed by the mother of the detenu, namely, Sudalaimuthu, S/o.Chellaiah, aged about 23 years, challenging the detention order in No.18/BCDFGISSSV/2021 dated 30.03.2021, passed by the second respondent, branding him as "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982.



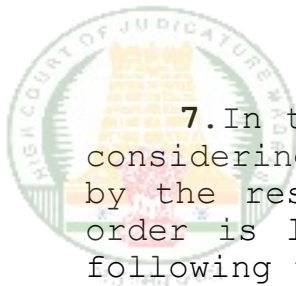
2. Even though the petitioner has raised several grounds to quash the impugned detention order, the learned counsel for the petitioner would mainly place arguments on the ground of delay in disposal of the petitioner's representation. In this regard, the learned counsel for the petitioner would state that the procedural safeguards guaranteed under Articles 21 and 22 of the Constitution of India have not been followed in this case and there is unexplained and inordinate delay in disposal of the petitioner's representation which would vitiate the impugned order of detention.

3. Mr. S. Ravi, the learned Additional Public Prosecutor, appearing for the respondents would state that after satisfying with the materials placed by the sponsoring authority, the detaining authority has passed the impugned detention order and therefore, there is no infirmity or illegality in the same. He would produce the proforma regarding the disposal of the petitioner's representation and would state that even if there is any delay in disposal of the petitioner's representation, it has not caused any prejudice to the rights of the detenu. Thus, he would pray for dismissal of this petition.

4. Heard the learned counsel for the petitioner as well as the respondents.

5. Perusal of the proforma furnished by the learned Additional Public Prosecutor appearing for the respondents would show that as against the impugned detention order, the petitioner made a representation to the first respondent dated 15.04.2021 and it was received on 19.04.2021. Remarks were called for on 19.04.2021 and it was received on 30.04.2021. The Deputy Secretary dealt with the matter on 05.05.2021. The concerned Minister dealt with the matter on 08.05.2021 and the representation came to be rejected on 07.06.2021. It is seen that in between 19.04.2021 and 30.04.2021, there was a delay of 10 days, after excluding the Government Holidays of 2 days, there was a delay of 8 days in I part and in between 08.05.2021 and 07.06.2021, there was a delay of 28 days, after excluding the Government Holidays of 10 days, there was a delay of 18 days in II Part and in total, there was a delay of 26 days in considering the petitioner's representation.

6. At this juncture, it is useful to refer the decision of the Honourable Apex Court in the case of **Rajammal vs. State of Tamil Nadu and another**, reported in **1999 (1) SCC 417**, wherein, the Apex Court has observed and held that it is for the Authority concerned to explain the delay, if any, in disposal of the representation and if any delay was caused on account of nay indifference or lapse in considering the representation, such delay will adversely affect further detention of the prisoner.



7. In the case on hand, as stated supra, the delay of 26 days in considering the representation of the petitioner remains unexplained by the respondents. Hence, in our considered view, the detention order is liable to be set aside solely on the ground of delay by following the above decision of the Apex Court.

8. In fine, the Habeas Corpus Petition is allowed. The detention order in No.18/BCDFGISSSV/2021 dated 30.03.2021, passed by the second respondent, is set aside. Consequently, the detenu, namely, Sudalaimuthu, S/o.Chellaiah, aged about 23 years, who is now detained at Central Prison, Palayamkottai, is directed to be released forthwith, unless her presence or custody or detention is required in connection with any other case.

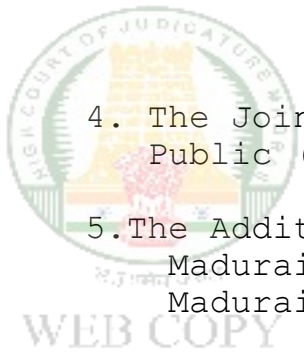
