PRAYER : Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus, calling for the records relating to the Detention Order passed by the second respondent in his proceedings Cr.M.P.No.07 of 2020, dated 20.02.2020 and quash the same and direct the respondents to produce the body of the person and Detenu namely, Sathishkumar, S/o.Balasubramanian, aged 25 years (now detained at Central Prison, Trichy), before this Court and set him at liberty.

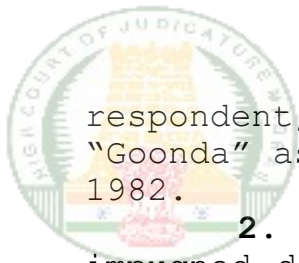

O R D E R

(Order of the Court was made by K.KALYANASUNDARAM, J.)

This habeas corpus petition has been filed by the mother of the detenu, namely, Sathishkumar, son of Balasubramanian, aged about 25 years, against the detention order passed by the second respondent.

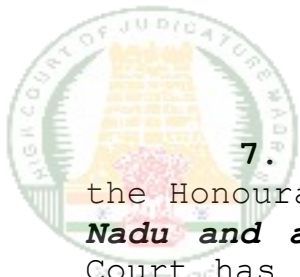
2. Though several grounds have been raised challenging the impugned detention order, Mr.N.Anandakumar, learned counsel for the petitioner, would mainly contend that the impugned order of detention is liable to be set aside on the grounds of failure of intimation of arrest of the detenu either to his family members or his relatives and delay in considering the petitioner's representation.

3. Per contra, Mr.R.Anandharaj, learned Additional Public Prosecutor, on instructions, submitted that the detention order has been rightly passed by the second respondent taking note of the activities of the detenu and it has been passed to prevent the detenu from indulging in similar activities in future. It is the further submission of the learned Additional Public Prosecutor that the arrest of the detenu has been properly intimated to his family members and the delay in disposal of the representation has not caused any prejudice to the detenu and hence, prayed for dismissal of the habeas corpus petition.

4. We have heard the rival submissions and perused the materials placed on record.

5. In the case on hand, though it is contended by the learned Additional Public Prosecutor that the arrest of the detenu has been properly intimated to the family members of the detenu, a perusal of Page No.38 of the booklet would show that the arrest of the detenu in the ground case on 17.12.2019 was intimated to Cell No.7373664949, but there is nothing on record to show that said cell number belongs to the family members or relatives of the detenu. This Court, following the decision of the Honourable Apex Court in the case of **D.K.Basu vs. State of West Bengal**, reported in **AIR (1997) SC 610**, in several cases, has consistently held that if there is no proper intimation of arrest of the detenu either to his family members or his relatives, his valuable rights would be seriously prejudiced on the sense that they will not have the opportunity to make effective representation to the Authority concerned in time for revocation of the detention order.

6. Further, it is seen from the proforma furnished by the learned Additional Public Prosecutor that the representation of the petitioner, dated 10.06.2020, was received on 16.06.2020. Remarks were called for on 16.06.2020 and it was received on 01.09.2020. The Deputy Secretary dealt with the matter on 01.09.2020. The concerned Minister dealt with the matter on 07.09.2020 and the representation came to be rejected on 07.09.2020. It is seen that in between 16.06.2020 and 01.09.2020, there was a delay of 76 days, after excluding the Government Holidays of 23 days, there was a delay of 53 days in considering the petitioner's representation.



7. At this juncture, it is useful to refer the decision of the Honourable Apex Court in the case of **Rajammal vs. State of Tamil Nadu and another**, reported in **1999 (1) SCC 417**, wherein the Apex Court has observed and held that it is for the Authority concerned to explain the delay, if any, in disposal of the representation and if any delay was caused on account of nay indifference or lapse in considering the representation, such delay will adversely affect further detention of the prisoner.

8. In the case on hand, as stated supra, the delay of 53 days has not been properly explained by the respondents. Hence, in our considered view, the detention order is liable to be set aside on the grounds as stated above by following the decisions of the Honourable Apex Court referred supra.

9. In fine, the Habeas Corpus Petition is allowed. The order of detention passed by the second respondent, in Cr.M.P.No.07 of 2020, dated 20.02.2020, is set aside. Consequently, the detenu, namely, Sathishkumar, son of Balasubramaniyan, aged about 25 years, who is now detained at Central Prison, Tiruchirappalli is directed to be released forthwith unless his presence or custody or detention is required in connection with any other case.

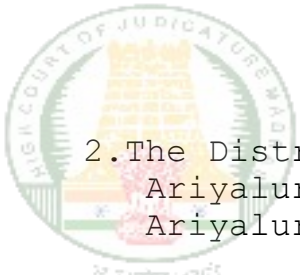
