Prayer in CRL OP (MD). 4293/ 2021 :

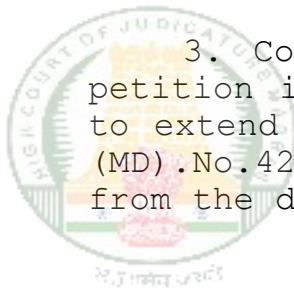
