Prayer

Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971, to punish the contemnor/ third respondent for the willful deliberate disobedience of the order passed by this Court in W.P.(MD)No.6086 of 2020 dated 26.05.2020.

Prayer in WP(MD). 6086/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the Respondent Nos.1 to 3 to issue Equivalent certificate to the petitioner clarifying that the B.C.S (Bachelor of Corporate Secretaryship) awarded by the Respondent No.3 University as equivalent to B.Com Degree for the purpose of employment in public services by extending the benefit of Government order in G.O(Ms). No.55 Higher Education (K2) Department dated 15.03.2018 passed by the Respondent NO.1 within the time Stipulated by this Court.
