Prayer :-

This Writ petition filed under Article 226 of Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to call for the records pertaining to the impugned order of the Respondent No.2 in F1/PR-74/2019 dated 08.04.2021 and quash the same as illegal and consequently direct the Respondent No.1 to 3 defer all further proceedings in connection with Tha.Pa.No.74/2019 on the file of the Respondent No.1 dated 02.12.2019 till the conclusion of the criminal trial in C.C.No.45/2020 on the file of the Judicial Magistrate Vadipatti in Crime No.150 of 2019 on the file of the Kadupatty Police Station, Madurai District.
