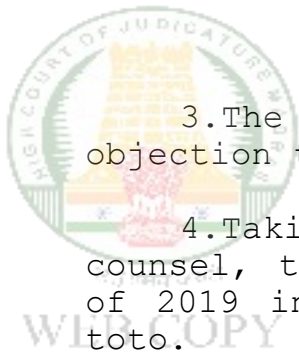
PRAYER IN Crl.R.C(MD)No.751 of 2019:
