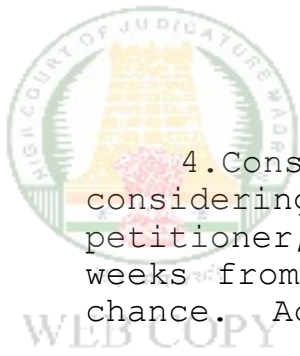
Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to extend the time to furnish sureties and also to deposit 7 bags of rice in CRL OP (MD) No.3510 of 2021 dated 05.03.2021.

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.T.Lenin Kumar, Advocate for the petitioner and of Government Advocate (Crl.side) on behalf of the Respondent, the Court made the following order:-

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.3510 of 2021 dated 05.03.2021, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioner would submit that the address where petitioner was directed to deposit 7 bags of rice was found incorrect and hence, the petitioner approached this Court to correct the address. Therefore, the petitioner was unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
