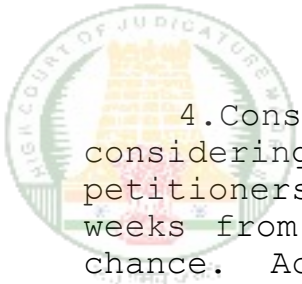

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.13349 of 2020 dated 24.11.2020, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioners would submit that due to COVID-19 situation, the petitioners were unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
