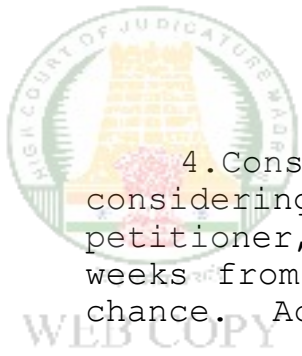

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.4040 of 2021 dated 17.03.2021, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioner would submit that due to COVID-19 situation, the petitioner was unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
