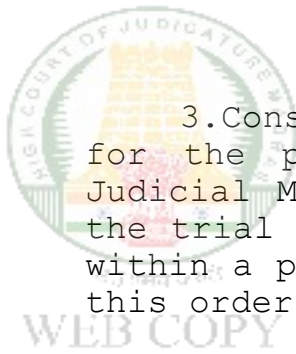

This criminal original petition has been filed seeking a direction to the learned Judicial Magistrate-I, Nagercoil, Kanyakumari District, to expedite and conclude the trial in C.C.No.36 of 2018 pending before the learned Judicial Magistrate-I, Nagercoil, Kanyakumari District, in Crime No.156 of 2016 dated 29.03.2016 on the file of the respondent.

2.The petitioner is the complainant before the trial Court in C.C.No.36 of 2018 and the case has been registered under Sections 294(b), 323, 324 and 506(ii) of I.P.C in Crime No156 of 2016. The crime is of the year 2016. The grievance of the petitioner is that even after lapse of five years, the trial is not completed and the matter is not disposed of by the trial Court and the accused is dragging on the matter endlessly.
