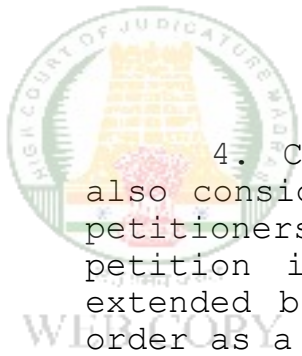

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.4519 of 2021 dated 31.03.2021, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioners would submit that the petitioners are unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

3.Heard the learned Government Advocate(Criminal Side) appearing for the State.

Considering the facts and circumstances of the case and also considering the submission made by the learned counsel for the petitioners and also the prevailing COVID-19 pandemic situation this petition is allowed and the time for producing the sureties is extended by two weeks from the date of receipt of a copy of this order as a last chance.
