Prayer in Crl.OP(MD) No. 11896 of 2017:

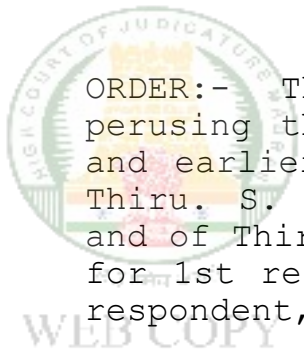
