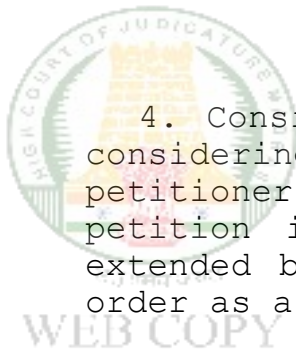

The petition has been filed to extend the time granted by this court in Crl.O.P(MD)No.4767 of 2021 dated 01.04.2021, for producing the sureties and for executing the bail bond.

The learned counsel appearing for the petitioner would submit that the petitioner was affected with corona and he was under self quarantine hence he is unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court.
