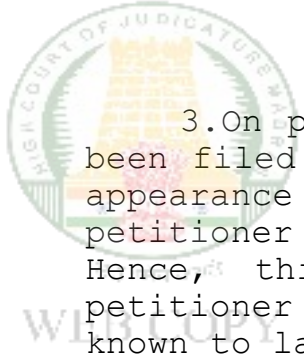
Prayer in CRL RC(MD). 385 of 2021 :
