2.The petitioner is a Non-Banking Finance Company (NBFC) and they seek for a direction to dispose of the application filed by

However, considering the present circumstances, we cannot issue any positive direction on account of reduced functioning of Court and reduced number of staff members. However, we can request the Court of the Chief Judicial Magistrate, Trichy, to dispose of the application as expeditiously as possible, soon after the Courts commence functioning after the Pandemic.
