The learned counsel for the petitioner would state that the impugned order under challenge was dated 24.01.2020 whereas the petitioner inadvertently has stated as 20.02.2020 the date on which the matter was adjourned. Therefore, he filed the amendment application to amend the date of order passed in E.P.No.87 of 2019 in MCOP.No.67 of 2008 as 24.01.2020 instead of 20.02.2020.
