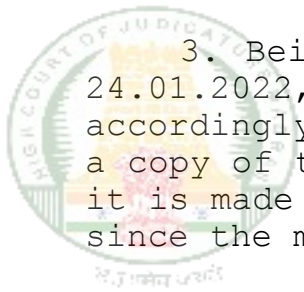
Prayer CRL OP(MD) . No.6582 of 2019:-
