Prayer in WP(MD). 19684/ 2018 :

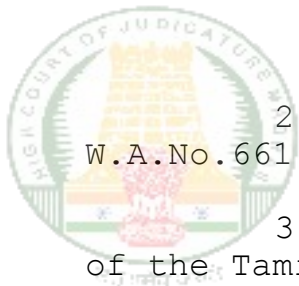
