Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned proceedings issued by the 4th Respondent Chief Educational Officer in Na.Ka.No.604/A1/14 dt. ...01.2015(refusing approval to the appointment of P.Antiles as Vocational Instructor in General Machinist, B.S.Jeeva as Vocational Instructor in Electrical Machines and Appliances and R.Meenakshi Sundaram as Vocational Instructor in General Machinist) in the petitioners School, quash the same and further Direct the 4th and 5th respondents herein to approve forthwith the appointment of P.Antiles as vocational Instructor in General Machinist, B.S. Jeeva as Vocational Instructor in Electrical Machines and Appliances and R.Meenakshi Sundaram as Vocational Instructor in General Machines w.e.f. their respective dates of appointment voz., 14.06.2004 and 04.04.2007, with Salary and all attendant benefits.
