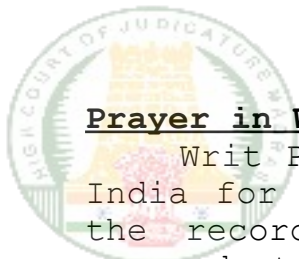

PRAYER IN CONT. P (MD) Nos. 582 & 584 of 2020: Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971 to punish the respondents herein for their deliberate and willful disobedience of the Order of this Court dated 26.11.2019 in Writ Petition (MD) Nos. 16807 of 2019 and 12882 of 2019 amounting to Contempt of Court under Article 215 of the Constitution of India read with Section 11 of the Contempt of Courts Act, 1971, and pass orders.

Prayer in WP(MD). 16807/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India for issuance of Writ of Certiorari, calling for the records relating to the impugned charge memo in proceedings in Tha.Pa.No.59/2019 dt.4.5.2019 (received on 13.5.2019) issued by the 3rd respondent superintendent of police, Dindigul District quash the same.



Prayer in WP(MD). 12882/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India for issuance of Writ of Certiorarified Mandamus, calling for the records relating to the impugned order issued by the 1st respondent in Letter (D) No.1448 Home(Pol.2) Department dated 14/12/2018, quash the same and further direct the respondents herein to allow the petitioner forthwith to retire on Voluntary Retirement basis w.e.f.20/12/2018 with all retrial and attendant benefits.

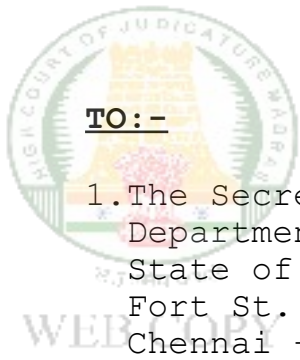
