Prayer in WP(MD). 804/ 2020 :

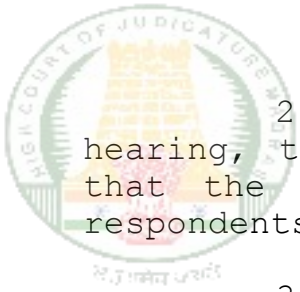
