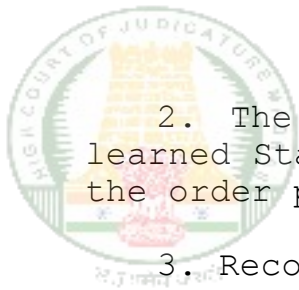
Prayer in WP(MD)Nos.24940, 24939, 24943 & 24942 of 2019:
