2.This Court, by order dated 20.04.2021 made in Crl.O.P(MD)No. 5357 of 2021, granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, the petitioner approached this Court with the present petition for extension of time.

3.Heard the learned counsel for the petitioners and the learned Government Advocate (Crl. Side) for the respondent police.



4.Considering the reasons stated in the petition, this petition is ordered and the time to comply with the order is extended by two weeks from the date of receipt of a copy of this order.
