This petition is filed to extend the time limit of the petitioners' surrender and execute the sureties in Crl.M.P.(MD) No.2800 of 2021 in Crl.O.P(MD)No.644 of 2021, dated 31.03.2021.

2.This Court, by order dated 25.02.2021 made in Crl.O.P(MD)No. 644 of 2021, granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, they have approached this Court with the present petition for extension of time.

3.Heard the learned counsel for the petitioners and the learned Government Advocate (Crl. Side) for the respondent police.



4.Considering the reasons stated in the petition, this petition is ordered and the time to comply with the order is extended by two weeks from the date of receipt of a copy of this order.
