Prayer : Criminal Original Petition filed under Section 482 Cr.P.C., to direct the 1st Additional District Judge (PCR), Trichy, to dispose the bail application filed by the petitioner on merits on the same day of his surrender before the above mentioned concerned Court in pending investigation of Crime No.276 of 2021, on the file of the Sub Inspector of Police, Lalgudi Police Station, Trichy District.

ORDER

The petitioner is the sole accused in Crime No.276 of 2021 on the file of the second respondent for the offences punishable under Sections 294(b), 323, 324, 506(i) of IPC and Sections 3(1)(r) and 3(1)(s) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015.

2.The present petition filed by the petitioner is to direct the learned 1st Additional District Judge (PCR), Trichy, to accept the surrender of the petitioner and also to consider the bail application



3.Mr.A.Robinson, learned Government Advocate (crl.side) accepts notice for the respondents 1 and 2. The third respondent is the de-facto complainant.

4.Since the prayer itself is to accept the surrender of the petitioner and consider the bail application, this Court is inclined to pass the following orders :-

1)The petitioner should appear before the learned 1st Additional District Judge (PCR cases), Trichy, within a period of 15 days from the date of receipt of a copy of this order / uploading of the order.

2)On such surrender along with notice served to the defacto complainant, concerned Judge, may consider the bail application filed by the petitioner on merits on the same day of surrender, after hearing the defacto complainant and by complying with Section 15(5) of the Act.

5.With the above observation, this Criminal Original Petition is disposed of.
