PRAYER :- For Anticipatory Bail in Crime No.9 of 2021 on the file of the respondent Police

ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent.

2. The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under sections 9(f), 9(1) and 10 of Protection of Children from Sexual Offences Act, in Crime No.9 of 2021 on the file of the respondent police, seeks anticipatory bail.

3. The learned Government Advocate (Crl. Side) states that complaints have been received from as many as eight girl students against the petitioner, who is their teacher. He also would state that statements under Section 164 of Cr.P.C., are going to be recorded. If after investigation, there is no material against the petitioner herein, the petitioner is at liberty to renew his criminal original petition for the relief of anticipatory bail.



4. With this liberty to the petitioner, this criminal original petition is dismissed.
