PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

PRAYER :- For Anticipatory bail in Crime No. 77 of 2021 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner, apprehending arrest at the hands of the respondent police in connection with the case in Crime No.77 of 2021 for the offence under Sections 174 Cr.P.C. @ 302, 207 IPC @ 147, 148, 120(b), 302 & 201 IPC, has filed this petition seeking anticipatory bail.

2. When the matter is taken up for hearing today, learned Additional Public Prosecutor, on instructions, submitted that this is a second application filed by the petitioner for anticipatory bail. The earlier application filed by the petitioner in Crl.OP(MD) No.6493 of 2021 was dismissed by this Court on 05.05.2021 and suppressing this fact, the petitioner has moved the present application.



3. Learned Counsel appearing for the petitioner submitted that he was not instructed about the earlier application filed by the petitioner and therefore, sought permission to withdraw the present application.

4. In view of the same, this Criminal Original is dismissed as withdrawn.
