Prayer in WP(MD) . 4612/ 2020 :

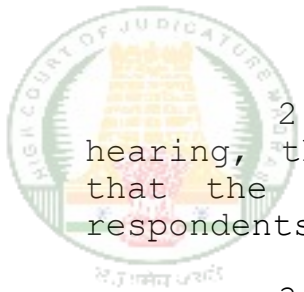
