When the matter is taken up for hearing, the learned counsel for the petitioner as well as the learned Standing Counsel for the State appearing for the respondents, by producing a copy of G.O.Rt.No.2709, Home, Prohibition & Excise (XII) Department, dated 18.06.2021, would state that the impugned detention order has been revoked.
