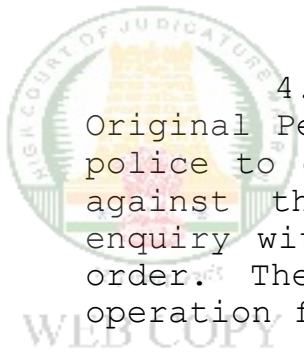
For Anticipatory Bail in Crime No not known of 2021 on

The petitioners, who apprehend arrest at the hands of the

learned Additional Public Prosecutor appearing for the respondent
Police submitted that the petition enquiry in CSR No.9 of 2021 is
pending against the petitioners.

3.The learned Counsel appearing for the petitioners
submitted that the respondent police is harassing the petitioners
under the guise of enquiry.



4.Considering the facts and circumstances, this Criminal Original Petition is disposed of with a direction to the respondent police to conduct the enquiry and if any *prima facie* case made out against the petitioners, register F.I.R or close the petition enquiry within a month from the date of receipt of a copy of this order. The petitioners are also directed to extend their co-operation for completing the investigation.
