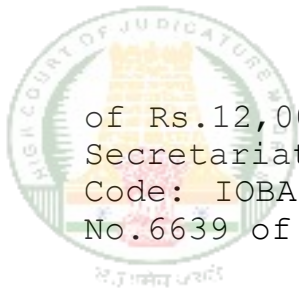

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.VISHNURAM.G., Advocate for the petitioners and of Mr.S.RAVI, Additional Public Prosecutor on behalf of the Respondent, the Court made the following order:-

This petition is filed to extend the time to surrender and execute sureties in pursuance to the order of this Court dated 12.05.2021 made in Crl.O.P.(MD).No.6639 of 2021.

2. Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor for the respondent.

3. Considering the reasons stated in the petition and also considering the prevailing covid-19 pandemic situation, this petition is ordered and the time to surrender before the concerned Court and execute the sureties is extended by one month from the date of resumption of regular work in the Courts, failing which the anticipatory bail already granted by this Court shall stand cancelled. Further, time is granted for one week to deposit a sum



of Rs.12,000/- (Rupees Twelve Thousand Only) to the credit of IOB, Secretariat Branch, Chennai-9 (Account No.11720 10000 00070, IFSC Code: IOBA0001172, which is imposed by this Court in CRL.O.P(MD). No.6639 of 2021 on 12.05.2021.
