PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No.37 of 2021 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/Sole accused, who apprehends arrest at the hands of the respondent police for the alleged offences punishable under Sections 379 of IPC r/w 4(1)(1A), 21(1) of Mines and Minerals (Development and Regulation) Act 1957 in Crime No.37 of 2021, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner illegally transported Kanmoi soil without valid permission from the authorities.

3.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondent.

4.This is the second anticipatory bail application and the earlier petition was dismissed by this Court on 13.05.2021 in Crl.O.P.(MD)No.6430 of 2021.



5. Taking into consideration the fact that there is no change in circumstances of the case, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
