It is submitted by the learned Standing Counsel appearing for the State that the representation of the petitioner, dated 01.06.2021, was considered by the second respondent and the Convict Ramanathan was granted leave for a period of six days excluding travel time. A copy of the order dated 03.06.2021 is also placed on record.

4. In the light of the above fact, we are of the opinion that the prayer sought for in this writ petition has become infructuous. Hence, this writ petition is closed.
