The learned counsel appearing for the petitioner would submit that he is affected with corona and he is under self quarantine, hence he is unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.

3. Heard the learned Government Advocate(Criminal Side) appearing for the State.

4. Considering the facts and circumstances of the case and also <https://hcservices.judg.in/hcservice/> submission made by the learned counsel for the



petitioners and also the prevailing COVID-19 pandemic situation this petition is allowed and the time for producing the sureties is extended by two weeks from the date of receipt of a copy of this order as a last chance.
