PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in Crime No.64 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

Heard the learned counsel on either side.

2.The petitioner apprehends arrest at the hands of the respondent police for the offences punishable under section 436 of IPC in Crime No.64 of 2021 on the file of the respondent police and seeks anticipatory bail.

3.The prosecution would claim that the property worth Rs.2 lakhs was damaged. However, the petitioner's counsel has mentioned that according to the Village Administrative Officer concerned, the value of the damage will not be more than Rs.15,000/-. The petitioner's counsel would also state that there is already a dispute between the parties and that the defacto complainant after setting fire on his own has given a false complaint.

4.The petitioner undertakes to deposit a sum of Rs.10,000/- to the credit of Cr.No.64 of 2021 before the jurisdictional Magistrate within a period of four weeks from the date of receipt of a copy of



5. Subject to this condition, this Court is inclined to grant anticipatory bail to the petitioner.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest by the respondent police on executing personal bonds for a sum of Rs.5,000/- [Rupees Five Thousand only] with two sureties each for a likesum to the satisfaction of the respondent police and on further condition that the petitioner shall appear before the Judicial Magistrate Court, Thirumayam, Pudukkottai District and execute fresh personal bonds for a sum of Rs.5,000/- [Rupees Five Thousand only] with two sureties each for a likesum to the satisfaction of the concerned Judicial Magistrate, within a period of one month, from the date of resumption of regular work in subordinate Courts in view of the present pandemic situation and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bonds and the Magistrate may obtain a copy of their Aadhar cards or Bank pass Books to ensure their identity;

[b] the petitioner shall report before the respondent police as and when required for interrogation;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***; and

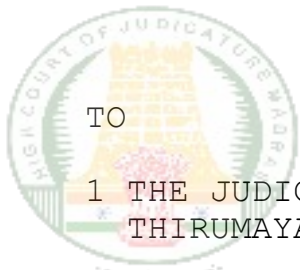
[f] If the accused thereafter abscond, a fresh FIR can be registered under Section 229A IPC.
