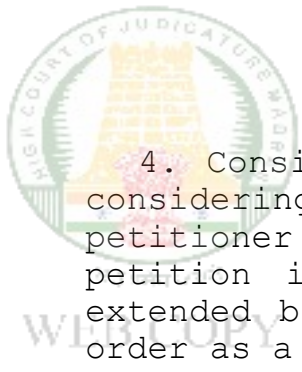

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.JEYAKARTHIK M.S, Advocate for the petitioner and of Mr.M.MUTHUMANIKKAM, Government Advocate (Crl.side) on behalf of the Respondent, the Court made the following order:-

The petition has been filed to extend the time granted by this court in Crl.M.P(MD) No.3560 of 2021 in Crl.O.P(MD)No.4697 of 2021 dated 30.04.2021, for producing the sureties and for executing the bail bond.

2. The learned counsel appearing for the petitioner would submit that this is the second extension petition and the petitioner is unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
