PETITION FOR MODIFICATION Under Sec.439(1) (B) r/w 482 of Cr.P.C

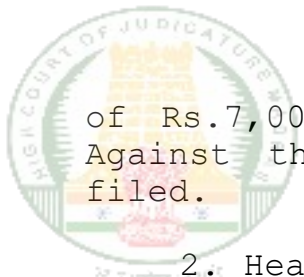
PRAYER :-
