3.Taking into consideration the subsequent development, wherein, the objections made by the petitioner has been rejected, nothing survives in this writ petition to be adjudicated. The first respondent shall serve the copy of the rejection order to the petitioner and it is left open to the petitioner to proceed further in the manner known to law.

4.This writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
