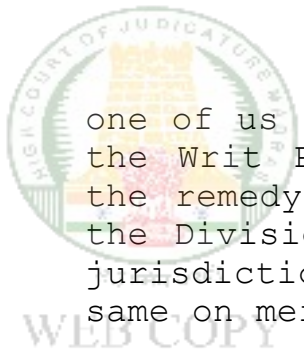

one of us (Hon'ble Mrs. Justice S.Ananthi) is a party, has closed the Writ Petition, giving liberty to the petitioner to work out the remedy in the manner known to law. In tune with the order of the Division Bench, if the petitioner files a petition before the jurisdictional designated Court, such Court shall dispose of the same on merits and in accordance with law.
