2.The learned counsel appearing for the petitioners would submit that the first petitioner's brother died due to COVID-19 and hence, they are unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
