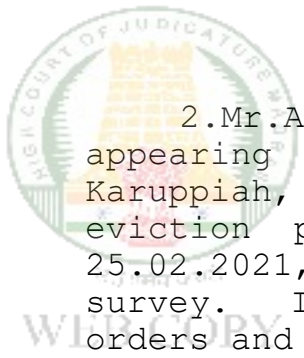

2.Mr.A.K.Manickam, learned Standing Counsel for Government, appearing for the respondents submitted that the encroacher one Karuppiah, had filed W.P.[MD]No.3620 of 2021, challenging the eviction proceedings, in which, an order has been passed on 25.02.2021, directing an enquiry to be conducted after conducting survey. It is submitted that the Tahsildar has passed necessary orders and survey is scheduled to be held on 26.07.2021.

3.In the light of the above, the respondents are directed to comply with the directions issued in W.P[MD].No.17451 of 2020 dated 04.12.2020.
