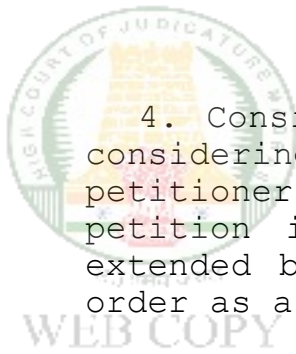

The learned counsel appearing for the petitioners would submit that due to ill health the petitioners are unable to arrange sureties and could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
