3. In view of the above, the Writ Petition stands dismissed as withdrawn. No costs.

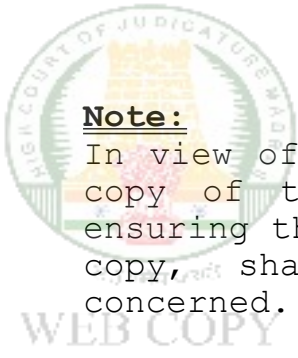
